Since its inception, nearly 400 women have lived in this facility as a transitional program that helps them develop a network of supportive relationships after they leave. Operations at Greenwich House have been discontinued and the related real estate was sold in December 2008. Spring Valley Shelter provides housing & support services to families & individuals who are homeless so they can move into stable housing. In 2008, our program housed 406 individuals, 250 of which were children. 79% of our participants, who completed an exit summary, found permanent See Form 990, Page 2, Part III, Line 4a (continued)
